Residency Review **Committee Appointments**

As of 1985, The Society of Nuclear Medicine (SNM) has become a cosponsor of the Residency Review Committee for Nuclear Medicine (RRCNM), a body of six appointed members which accredits training programs.

The committee was established in 1973 with two sponsors, the American Medical Association (AMA) and the American Board of Nuclear Medicine (ABNM), and both organizations appointed three members for three-year terms, explained B. Leonard Holman, MD, director of clinical nuclear medicine at Brigham & Women's Hospital in Boston, and chairman of the RRCNM.

Last year, the AMA and ABNM approved the Society's petition to become a sponsor, and each group now appoints two members to the committee.

Michael J. Welch, PhD, immediate past president of the Society, appointed during his term in office two SNM members to serve on the RRCNM: Peter T. Kirchner, MD, director of nuclear medicine at the University of Iowa Hospitals and Clinics; and Robert J. Cowan, MD, director of nuclear medicine at North Carolina Baptist Hospital.

Training Criteria Debate Reopened

At the Society's Business Meeting last month in Houston, TX, Herbert C. Allen, Jr., MD, a private practitioner at Nuclear Medical Laboratories in Houston, reopened the debate on training and experience criteria required by the U.S. Nuclear Regulatory Commission (NRC) for physicians performing cardiovascular nuclear medicine studies (see Newsline: Mar. 1985, pp. 220-223; June 1985, pp. 557-558).

By introducing a resolution from the floor, calling for the Society to support six months of training for all physicians instead of four months for cardiologists and six months for other physicians practicing nuclear medicine, Dr. Allen tried to get a group of the general SNM membership to overrule the resolution passed by the Board of Trustees last January at the Winter Meeting in Las Vegas.

Stanley J. Goldsmith, MD, who took office as president of the Society last month, made a motion for a substitute resolution to refer the question back to the Board of Trustees to discuss again at its Winter Meeting next February in West Palm Beach, FL. Dr. Goldsmith's resolution was adopted by members attending the Business Meeting.

SNM Forms Cardiovascular Council

Several members of The Society of Nuclear Medicine (SNM) are organizing a Cardiovascular Council for nuclear cardiologists and cardiovascular nuclear medicine physicians.

"Although the scientific, clinical, and financial impact of this imaging subspecialty is well appreciated, there is no defined and specific focus for interchange and consideration of topics of mutual interest," said Elias H. Botvinick, MD, associate professor of medicine and radiology at the University of California in San Francisco.

"An SNM Cardiovascular Council could further the scientific and educational goals related to this imaging modality," added Dr. Botvinick.
