Funds for a student fellowship have been donated by friends and family of the late Joseph Sternberg, MD (1912-1991), an endocrinologist-nuclear physician and a pioneer of nuclear medicine. In recognition of his scientific achievements and his contributions to the establishment of the field of nuclear medicine, a fund has been set up in his memory to further the training of a selected young scientist in nuclear medicine.
