ANNOUNCEMENT AND CALL FOR ABSTRACTS FOR SCIENTIFIC PROGRAM

The Scientific Program Committee welcomes the submission of abstracts of original contributions in nuclear medicine from members and nonmembers of the Society of Nuclear Medicine. Papers will be considered on the following subjects:

- Clinical diagnosis
- Clinical investigation
- Basic science relating to physiology, metabolism or nuclear phenomena
- Radiopharmacology
- Radioisotope therapy
- Nuclear instrumentation
- Radiation biology

Papers will be selected for presentation at Plenary Sessions as well as at Scientific Section Meetings.

GUIDELINES FOR SUBMITTING ABSTRACTS:

Abstracts *must* be submitted in the following format to receive consideration. The length must not exceed 400 words. Abstracts are to be typed (double spaced in lines containing 50 characters) on the official abstract form which can be obtained from a member of the Society or by writing The Society of Nuclear Medicine, 211 E. 43rd St., New York, N.Y. 10017. Three carbon copies on plain paper must also be submitted.

Each abstract *must* contain the name(s) of the author(s), their institution(s) and the mailing address of the author presenting the paper. Underline the name of the author who will present the paper.

Each abstract *must* contain the following information in this order:

1. Purpose of the study
2. Methods used
3. Results with pertinent supporting data
4. Conclusions

Abstracts that are accepted will be published in the June 1969 issue of *The Journal of Nuclear Medicine*.

So that each work will receive maximum consideration, authors are urged to submit to the Scientific Program Committee supplementary data (charts, graphs, figures, tables, etc.) supporting their abstracts. This material will not be published.
